

Blue Bandit admits he's kinda 'different'

Jurors find climber innocent in stunt

The tower-climbing Blue Bandit admitted to a jury Wednesday, "I've been kind of different ever since I was a little kid."

But his individualism apparently didn't bother the jurors, who found 'The Blue Bandit of Texas' innocent of criminal trespass for using suction cups to scale a 71-story skyscraper and parachute to the ground."The Blue Bandit of Texas' Stanley, who also goes by the name Skip Stanley, convinced jurors he was not told to get off the Allied Bank Plaza tower until he had no choice but to climb upward and then leap down. Stanley said he prepared for the long climb by using the suction cups on mirrors at his home. Stanley, who earned his nickname while bedecked in blue for the crowd-pleasing stunt last May, was charged with two misdemeanor offenses — criminal trespass and resisting arrest—in the court of County Court-at-Law Judge Jack Pickren.

Assistant District Attorney Joan Campbell said she hasn't decided yet if she'll prosecute Stanley, for allegedly eluding police after he parachuted from the building.

Stanley, also faces charges in Fort Bend County for climbing 2,000 feet up a television tower and paractuting off last December.

Campbell argued that Stanley was guilty of trespass because he was given ample notice that he should leave and was afforded several opportunities.

Stanley, refused and climbed to within a few floors of the top of the tower to "feed his ego," Campbell said.

Defense attorney Randy Holzapple told the jury Stanley didn't hear Allied officials' demands that he get off the building and leave until he had reached the 20th floor.

By then, Stanley's only choice was to finish the climb so that the parachute drop would be safe, Holzapple said.

"There's no law against climbing on the out-side of a building," Holzapple argued. "He was told to leave. He left."

Holzapple called his 21-year-old client a hero and said the prosecutor's efforts to punish Sta.

nley amounted to "stamping out individualism."
Stanley, who plans to legally change his name to Skip Stanley, said he wants to perform more stunts — but only for charity.
"I want to do this legitimately and for a good cause," he said, though noting that Texas Chlidren's Hospital refused to sanction one suggestion of jumps for charity because of the danger. He had suggested 100 parachute jumps in a 24-hour period.
